Innovation pedagogy is a specific learning approach, which aims to enhance students' individual, interpersonal and networking innovation competences needed in the future working life. To achieve the competences the whole learning environment must be created in a new way and learning methods must be reviewed. One key element is enriching teaching and learning with educational research, development and innovation (RDI) methods. The development process includes several cases and examples of the implementation of innovation pedagogy. The intensive training days are based on a wide variety of activating, experiential and collaborative methods.

Working life orientation, flexible curricula and multidisciplinary learning environments are essential requirements for innovation pedagogy to succeed. Renewing teacher's roles support, encourage and guide students in order to advance learning. Students need good study skills to take an active and responsible role in their own learning. The methods used

in delivering the education must be activating and versatile. Giving students opportunities to work in real-life assignment and research & development projects is essential when aiming to improve their innovation. The assessment is development-oriented, i.e. students are able to assess their own and peers' competences and know how to develop them. Entrepreneurship and entrepreneurial attitude are encouraged, and internationalization is embedded into studies in versatile ways

PURPOSE OF THE INNOPEDA® MANAGER TRAINING

Innopeda® Manager Training is targeted especially for management, lecturers, education planners and RDI personnel. The objective of this training is to guide participants through a holistic development process to implement Innovation Pedagogy in your Health care education institution. The training is included in development process as well as the implementation and monitoring of the change. It may include staff exchange, site visits, process consulting and coaching. Content and follow up during the process:

- Experiencing the authentic Finnish educational culture in Finland
- Analysis of current situation
- Making the change – Conducting a personalized development plan at your institution according to Innovation Pedagogy
- Innovation Pedagogy intensive training in Finland and on client's premises (Covid -19 allowing) and online
- Activating methods for making the change with Innovation Pedagogy for increasing for increasing future health care professionals' competences and working towards the sustainable future

Extent and timing: The development process takes approximately ten (10) months. An online kick-off session with Zoom could be arranged during spring 2022, followed by a study visit to Finland before summer vacations. The training would continue until the end of 2022, including training onsite in Brazil. A separate schedule will be agreed with UFCSPA.

1 RESPONSIBILITIES OF TURKU UNIVERSITY OF APPLIED SCIENCES:

- To organize the training entities
- To organize a technical study visit to Turku, Finland and tailored to the needs of UFCSPA with a separate agenda and schedule.
- To provide access to “itslearning” LMS, an online learning environment of Turku UAS
 - All learning materials are provided translated to Portuguese and in electronic format for easy access
- To appoint necessary Innopeda® Expert Trainers to implement the training entities throughout the process
 - In addition Turku UAS will use various professionals to address specific topics e.g. as key notes
- To provide online sessions (e.g. Zoom Webinars) and onsite sessions according to a separate implementation plan
- To provide certificates for successful participants
